Speed Limit signs – This past year the county has posted the speed limit in the SVE community to 25 MPH. In an active community with pedestrians and children, safety is critical. Please maintain safe speeds when driving through the community.

Assessment of tree removal – The board concluded an assessment to remove the maturing forest of SVE. In the end, it was deemed to complex. The forest could benefit from removal of mature trees, but we have many property lines with multiple owners. It would be costly to survey the lots and communicate to all. This issue has been tabled for now.

Easement on corner of Schuss Mountain road and Cedar River Drive- The SVE sign and garden located at this intersection is on Lone Petoskey's property. Lonne has been kind enough to grant an easement to SVE to this property for the purpose on maintaining the sign and garden after property ownership changes. Thank you Lonne.

Entry sign and garden- I hope you have noticed the sign has been refreshed with a new coat of paint plus the garden has soil amendment with fresh flowers. It has a much-needed improvement this past fall. The sign and garden create a positive impression for the broader community.

Riverside Park – In 2018, we incurred extensive storm damage in Riverside park. This has been cleaned up and the mulch from the trees has been used to enhance the trail. Also, some of the boards were replaced along the boardwalk. This is beautiful spot so we encourage you to enjoy the park. There are logs available for firewood so help yourself to the wood.

This past July, we had another successful summer picnic in the Children's' park. Thank you to all who were involved in organizing and attending. It is fun to meet the neighbors and enjoy a meal together. We plan to have another picnic this coming July.

Lastly, we have recently become aware that one of the power companies in the area intends to enhance their infrastrure running through the community. The project plans and specifics have not been shared with us yet. We will pass this on to you as more becomes known. We expect there will be tree removal along the easement this winter with the power poles changed later this year. More to come on this topic soon.
